5	Provide me information How reliance officers Mr. Ram Chandra Kalanthare and Sr. Officer Mr Girish Sulakhe and Bilal Ansari have rights to refuse to give reconnection Electricity Connection to Liyakat Ali Yusuf Shaikh shakh, three application for electricity connection has been made in 9 years with all formalities but not provided on the issue of personal revenge taken by reliance officers Ram Chadra Kalanthare with electrical contractor Zari Wala Whether they can refuse the application of new Electricity Connection.		
6	Provided me information in how many working days taken by reliance officers if the consumers apply for new Electricity Connection.

8	Provide me information on dated 22/08/2018 by speed post Liyakat Ali Yusuf Shaikh send New meter application form duly filled and necessary documents attached along with Test Report and the same is received by MERC by speed post.		

Above table no. १, ३ to ८ has sought the information, as per the Central Govt., Ministry of Personnel, Public Grievances & Information can not include within its fold answers to the question "Why" which would be same thing as asking the reason for a justification for a particular thing. The PIO cannot expect to communicate to the citizen the reason why a certain thing was done or not done in the sense of a justification are matter within the domain of adjudication authorities and cannot properly be classified as information." This is not come under RTI. According to section २ (f) of the Act 'Information' means any material in any form.

In case, if you are not satisfied with our reply, you may approach to Shri Anilkumar Ukey (Dy. Director-Legal), who is Appellate Authority, within thirty days from the receipt of the information as provided under section 19(1) of RTI Act 2005.
