"3B. Procedure for seeking inspection of Records :- If after having considered the application filed by the applicants for seeking inspection of records under sub section (1) of section 6 the Public Information Officer finds it appropriate, the applicant may be granted permission to inspect the records and if he grants such permission the Public Information Officer shall requisition the record desired by the applicant for perusal, from the concerned section of the department and shall give the same to the applicant for inspection in his presence or in the presence of his authorized representative, during office hours. While inspecting such records, the applicant shall be allowed to use pencil only and the information desired by the applicant shall be noted by him by pencil only and if the applicant brings any writing instruments other than a pencil, he shall deposit the same with the Public Information Officer and thereafter, he shall be allowed to inspect the record. The applicant shall not make any marking on the record by the pencil he is allowed to use during inspection."
