Point No 2:- Details for new Connection are specified in the Standard of Performance Regulation, 2014. The copy of Standard of Performance Regulations, 2014 may be downloaded from the Commission website free of Cost.

Point No 3:- The Commission has specified Supply Code Regulations, 2005 and Standard of Performance Regulations, 2014, wherein the Distribution Licensee has to comply and fulfill its Universal Service Obligation to provide connection to the Consumers within stipulated time frame. The copy of the Supply Code Regulations, 2005 and Standard of Performance Regulations, 2014 can be downloaded from the Commission's website free of cost.

Point no 4:- Time Period in case of voltage Variation is specified in SOP Regulations, 2014. The said Regulations can be downloaded from the Commission's website.

Point no 5:- The Commission has notified SOP Regulations, 2014, which specifies the Voltage variation/quality of supply to consumers and time period to mitigate issue. The Copy of Standard of performance Regulations, 2014 can be downloaded from the Commission's website.

As per the Hon'ble CIC decision No. CIC/YA/A/2014/000379/SB Dated 19.09.2016 in the matter of Shri. K. Lall Vs M. K. 12.04.2007, since the same is available in public domain, the PIO is not obliged to provide the same to the appellant under the RTI Act.
