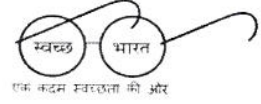

1	In month of October, 2018 I have written a mail to the chairperson of MERC, which was regarding the fair justice of 2 consumers, so I want to know what kind of which was regarding the fair justice of 2 consumers, so I want to know what kind of enquiry or action has been taken on the mail.	The applicant has attached the email sent on 9 October, 2018 at 5:55 PM with his application. In the said mail it has shown attached files of 19.4MB. The said email has not received.
2	I also want to know that, how your firm generates 3 phase TOD meter (i.e whether the bill issued as per cumulative KWH or it is issued as per cumulative TOD Zone).	The Commission does not generates any bills. The distribution License generates bills, hence it is proposed that said RTI application may be forwarded to the MSEDCL. *
3	In Case after the download of readings through MRI, there comes an error (i.e. there is a difference between cumulative kWH and cumulative TOD Zone), So whether they have to declare the meter faulty, which is as per the rules, or instead they have the rights to edit the copy of the data(ascii files) and issue the bill as per the edited data.	The Commission does not generates any bills or takes the MRI Readings. The distribution License generates bills and takes the MRI Data, hence it is proposed that said RTI application may be forwarded to the MSEDCL. *

* In this regards the question no. RTI is 12.d and 14.b, is to be consumed to all the licensees for the information sought by the applicant.
