The office of the Commission is in receipt of your application Dated 20.10.2021 under section 6 (1) RTI Act 2005 seeking information by the PIO as under:

1	I have a complain against Maharashtra Electric Board (Nagpur). I have a home at Bhilgaou, city Nagpur, Maharashtra area. I have taken electric connection of number 410130010826 from 2012 in 2017-19 I given this home to Deepak Titarmare for rent purpose as I am residing at Ahmedabad and my husband got cancer in 2018. During this period rented person don't pay the bill for 8-9 months and reaches 18990 Rs. pending bill. I am asking why MSEB not cut electric connection at 2 nd month when bill was not given by that person. In 8-9 months how many times MSEB person gone for bill collection and who is going to collect that electric bill. and in 2019 end power cut after bill reaches 18990. We have a doubt and also heard from neighbor that rented person given some money to MSEB employer.	Didn't specify which information required. Request you to ask specific information or send new RTI application for specific documents required. We will provide relevant document/ information as per the RTI Act, 2005 under section 2(f).**

** According to section 2(f) of the Act 'Information' means 'any material in any form'. Ministry of Personnel, Public Grievances & Pensions Department of Personnel Training No. 11/2/2008-IR dated 10th July, 2008. Careful reading of the definition of 'Information' and 'right to information' makes it clear that a citizen has a right to get the material, inspect the material, take notes form the material, take extracts or certified copies of the material, take samples of the material, take the material in the form of diskettes etc. The

PIO is required to supply such material to the citizen who seeks it. The Act, however, does not require the PIO to deduce some conclusion from the 'material' and supply the 'conclusion' so deduced to the applicant. The PIO is required to supply the 'material, in form as held by the public authority and is not deduce anything from the material and then supply it to him.
