a	Kindly provide inspection of all files pertaining to my electricity connection with Adani Electricity (Previously Reliance Energy) bearing A/C No. 152419437, Meter No. 9067095 in the Name of Arif Anis Khan, Book No. 210, Cycle No. 21, Division-East, Unit-16, Service 40A.	The requisite information pertains to other utility of Adani Electricity Mumbai Limited (formally known as Reliance Electric Generation and Supply Limited). Adani Electricity Mumbai Ltd. was informed in one of the RTI received from consumer vide its letter dated 20.10.2018 (copy attached) under Section 6 (3) of RTI Act, 2005. In reply to that Adani Electricity Mumbai Ltd. informed that. The Hon'ble Bombay High Court has by its order dated 13.10.2011, interalia stayed the Maharashtra State Information Commission's order dated 14.03.2011 they are not a 'public Authority' as defined under the provisions of Section 2 (h) of the Right to Information Act, 2005 and hence the provisions of the said RTI Act.
