CORRIGENDUM NO. 2

1. The Commission vide Notice Inviting Tender (2022_MERC_780209_1) has sought bids from qualified bidders for Redesigning, Development, Implementation, and Maintenance of Content Management System based Website and Integration with MERC e-filing Application
2. Based on the feedback received during pre-bid meeting held on 29 March 2022, following changes have been made in Tender document.

2.1 The Clause 1.1. Bidding Schedule, SL. No. – 9 & 11 is mentioned as below:

9.	Earnest Money Deposit (EMD) to be paid via Online Payment Gateway mode only.	Rs. 50,000/- (Rupees Fifty Thousand)
...
11.	RFP Document Fee to be paid via Online Payment Gateway mode only.	Rs.500/- (Rupees Five Hundred Only)

Now this criterion shall be read as follows:

9.	Earnest Money Deposit (EMD) to be paid via Online Payment Gateway mode only.	Rs. 50,000/- (Rupees Fifty Thousand) MSME Bidders are exempted for payment for EMD.
...
11.	RFP Document Fee to be paid via Online Payment Gateway mode only.	Rs.500/- (Rupees Five Hundred Only) MSME Bidders are exempted for payment for Tender Fees.

2.2 The Clause 2.21 Pre-Qualification Criteria - PQ6 is mentioned as below:

The Bidder shall have registered or service provider office in the State of Maharashtra

Now this clause shall be read as follows:

The Bidder shall have registered or service provider office in the State of Maharashtra. Otherwise, bidder shall submit the undertaking to open the office within 30 days of award of contract., failing which MERC at its own discretion may cancel the contract.

2.3 The Clause 2.21 Pre-Qualification Criteria PQ 2 (a) is as below:

The Bidder must have registered a turnover of Rs. 1 Crores or above in each year during the last three completed financial years (FY 2017-18, 2018-19, 2019-20), (Not inclusive of the turnover of associate work or companies).

Now this clause shall be read as follows:

The Bidder must have registered a turnover of Rs. 1 Crores or above in each year for the three financial years out of last five financial year. i.e. for FY 2017-18, 2018-19, 2019-20, 2020-21, 2021-22), (Not inclusive of the turnover of associate work or companies).

2.4 The Clause 2.24 Technical Evaluation Criteria TQ 2.1 is as below:

Bidder should have successfully developed at least three website or revamped UI / UX of web sites / portals / applications in the last 3 (Three) financial years (FY 2017-18, 2018-19, 2019-20)

Now this clause shall be read as follows:

Bidder should have successfully developed at least three website or revamped UI / UX of web sites / portals / applications in the last 5 (Five) financial years (FY 2017-18, 2018-19, 2019-20, 2020-21, 2021-22).

2.5 The Clause 2.24 Technical Evaluation Criteria TQ 3.1 is as below:

Technical Presentation detailing followings Understanding of Scope of Work by bidder Approach and Methodology for Project Implementation. Fully interactive clickable prototype of website

Now this clause shall be read as follows:

Not allowed. The Clause TQ 3.1 will remain as it is. The prototype shall be of basic level and will be useful to understand the conceptual understanding of scope of work by the bidder.

2.6 The Clause 4 Scope of Work 4.1 Brief Scope of Work is as below:

jj. The bidder will have to provide mandatory training for administrative users as per MERC's requirement as part of the scope of work, at no extra cost, during the entire contract period. The bidder will provide support for troubleshooting and enhancements in the services during the contract period

Now this clause shall be read as follows:

The Bidder shall provide two mandatory physical training to the MERC Teams before go-live of the website. During further three years of O&M, the Bidder has to provide the training to the person authorized by the MERC as and when required, through Video Conferencing mode.
