- B) The Chairperson shall preferably have working knowledge of the vernacular language of the State of Maharashtra.

2. Period of Contract

The Chairperson of the Forum shall hold office for a fixed term of three (3) years. The tenure of a Chairperson may be extended by the Commission for a further period not exceeding two (2) years subject to an overall age limit of sixty-five (65) years. As per the terms of Regulation 4.5 of MERC (Consumer Grievance Redressal Forum & Electricity Ombudsman) Regulation 2020.

- D) The Member shall not have been in the employment in any capacity under, or agency of, the Distribution Licensee or provided consultancy services to electricity consumers for a minimum period of three (3) years prior to being appointed as member of the Forum:
- E) Preference shall be given to a representative of a registered voluntary consumer protection organization or Industrial Association and preference shall be given to a person who resides in the same area of CGRF Location mentioned in Advertisement.
- F) Candidate shall not be less than 45 years of age at the time of submitting the applications.
