NOTIFICATION

Authorization of Individual Consumer Representatives

The MERC (Authorized Consumer Representatives) Regulations, 2012 provide that there shall be a 'Panel of Individual CRs' comprising of a maximum of fifteen Individual CRs authorized to represent the interests of electricity consumers (in Maharashtra), in the proceedings before the Maharashtra Electricity Regulatory Commission (the Commission or MERC).

Pursuant to Regulation 6 of the Maharashtra Electricity Regulatory Commission (Authorization of Consumer Representatives) Regulations, 2012, the Commission authorizes the following individuals as Consumer Representatives for representing the interests of the electricity consumers in Maharashtra in the proceedings before the Commission.

An **Individual CR** shall be authorized for a period of three years from the date of this notification.

The Commission may invite a suitable number of **Individual CRs** from the 'Panel of Individual **CRs**' on a case to case basis.

The **CR** shall perform the functions and duties assigned to him/her in accordance with Regulation 10 of the MERC (Authorized Consumer Representatives) Regulations, 2012.

The Commission shall seek submissions either in writing or orally from the concerned **CR** on a particular case or matter.

This Notification is being issued consequent to the recommendations of the Selection Committee, as provided by Regulation 5.4 of the Regulations.
