## PUBLIC NOTICE

### Case No.52 of 2013

#### NOTICE UNDER CLAUSE (a) OF SUB-SECTION (5) OF SECTION 15 OF THE ELECTRICITY ACT, 2003 (EA 2003)

1. An application for grant of licence for intra-state trading of electricity in the whole of Maharashtra has been made by M/s. D.M. Corporation Pvt. Ltd. (herein after referred as DMCPL), Mohite House, 240/B, Gen. Thorat Marg, Tarabai Park, Kolhapur-416003, Maharashtra.
2. In accordance with sub-section (2) of Section 15 of the Electricity Act, 2003, (EA 2003) DMCPL published a notice of its application on 12 July, 2013 in following newspapers:- The Times of India, Sakal Times, Maharashtra Times, Sakal, Tarun Bharat, Ratnagiri Times and Navabharat Times.
3. A copy of the application along with its Annexures and enclosures, made by DMCPL before the Commission can be accessed at the website "[www.dminfra.com](http://www.dminfra.com)" and at Commission's Website "[www.mercindia.org.in](http://www.mercindia.org.in) / [www.merc.gov.in](http://www.merc.gov.in)" or inspected by any person at the Commission's office by following the procedure laid down in the Maharashtra Electricity Regulatory Commission (Conduct of Business) Regulations, 2004.
4. On consideration of the material available on record, the Commission is satisfied that *prima facie*, the applicant qualifies for the grant of licence for intra-state trading in electricity for trading 50 MUs for the first year and gradually increase to 100 MUs over a period of five years. The Commission proposes to grant the licence for intra-State trading in electricity in the State of Maharashtra to the applicant, as category 'A' electricity trader in terms of Maharashtra Electricity Regulatory Commission (Trading Licence Conditions) Regulations, 2004 as amended by Maharashtra Electricity Regulatory Commission (Trading Licence Conditions) Regulations, 2006.
5. Notice is hereby given in pursuance of clause (a) of sub-section (5) of Section 15 of the EA 2003 to invite the suggestions or objections, if any, to the proposal to grant licence for intra-State trading of electricity in the whole of Maharashtra by the Commission to be received by the undersigned, **latest by 24, October 2013** at the above noted address. The suggestions or objections received after the specified date shall not be considered.
6. Every person who intends to file suggestions or objections can submit the same in English or Marathi, in six copies, and should carry the full name, postal address and e-mail address, if any, of the sender. It should be indicated whether the **suggestions or objections** is being filed on behalf of any organization or of any category of consumers. **The Commission has fixed the Public Hearing on Thursday, 31 October 2013 at 11:30 hours** at office of the Commission at 13th floor, Center No.1, World Trade Centre, Cuffe Parade, Mumbai 400 005, and the person who files the suggestions or objections may in his discretion attend the public hearing, for which no TA/DA shall be paid by the Commission..
