NOTIFICATION

ELECTRICITY ACT, 2003

No.ERC-2003/CR-171/NRG-3:- In exercise of the powers conferred by clause (i) of sub-Section (2) of Section 180 read with sub-Section (1) of Section 105 of the Electricity Act, 2003, the Government of Maharashtra hereby makes the following Rules, namely:

1. Short Title – The Rules may be called the Maharashtra Electricity Regulatory Commission (Preparation of Annual Reports) Rules, 2003.

2. Definitions:- (1) In these Rules, unless the context otherwise requires:-

(a) "Act" means the Electricity Act, 2003;

(b) "Annual Report" means the Report containing a summary of the activities undertaken by the Commission in a financial year, referred to in Section 105 of the Act;

(c) "Commission" means the Maharashtra Electricity Regulatory Commission, established under section 17 of the Electricity Regulatory Commissions Act, 1998 read with the proviso to sub-section (1) of section 82 of the Act;

(d) "Government" means the Government of Maharashtra.

(2) Words and expressions used but not defined herein shall

have the meanings respectively assigned to them in the Act.

3. Form of Annual Report: The Annual Report shall contain a summary of the activities undertaken by the Commission in a particular financial year, and any related matters as may be deemed appropriate by the Commission, such as the composition and powers and functions performed by the Commission, and the State Advisory Committee, a summary of Accounts, in the appended form 'A' and any other relevant information.


4. Period for preparation: The Annual Report in respect of any financial year shall be prepared by the Commission in Marathi and in English, and shall be forwarded to the Government as far as as possible within a period of

nine months of the close of the financial year to which it relates, in printed form and in the number required by the Government.

Provided that, the Report of the Commission in respect of the years upto and including the financial year ending on 31st March, 2002 may be prepared and forwarded to the Government, in composite form and as a single document, as soon as may be after the publication of the Rules.


5. Publication of Annual Report: The Commission may make available the Annual Report to the public by sale or in such other manner as it may deem appropriate, after it is laid before the State Legislature.
6. Interpretation: In case of any doubt regarding interpretation of the Rules, the same shall be referred to the Government, whose decision shall be final.
