# **PUBLIC NOTICE**

Objections/comments on Nidar Utilities Panvel LLP (NUPLLP) seeking approval of Power Purchase Agreement executed between NUPLLP and M/s The Tata Power Company Limited (Distribution Business) (TPC-D) for procurement of power under the provisions of Section 86 (1) (b) of the Electricity Act, 2003 and the Regulations made there under.

# (Case No. 117 of 2017)

- 1. Nidar Utilities Panvel LLP (NUPLLP) has filed a Petition for approval of Power Purchase Agreement executed between NUPLLP and TPC-D for procurement of power under the provisions of Section 86 (1) (b) of the Electricity Act, 2003 and the Regulations made there under.
- 2. The Commission has admitted the Petition on 31 January, 2018 and directed NUPLLP to publish a Public Notice under Section 64(2) of the Electricity Act, 2003 inviting Suggestions /Objections from the public.
- 3. The Commission, in its Daily Order dated 31 August, 2017 in Case No. 117 of 2017 had directed NUPLLP to submit the information on various issues. NUPLLP, on 28 September, 2017 and 27 October, 2017 has submitted information required by the Commission.
- 4. In its Revised Petition dated 6 December 2017, NUPLLP estimated the demand. Details of the estimated demand given as below:

- 5. The Tariff negotiated under the PPA is proposed to be a two-part Tariff;
- (a) Fixed Charge based on the Monthly Load Factor, shall be computed on the basis of scheduled energy against the Monthly Contracted Capacity as per Clause 5.3 of the PPA; and
- (b) Variable Charge are fuel charges based on the implemented energy schedule during the month for the as per Clause 5.3 of the PPA.
- 6. The Fixed Charge will be payable @ Monthly Load Factor of 85% of the Monthly Contracted Capacity as per Clause 5.3 of the PPA. The Fixed Charge is based on the MERC Order dated 8<sup>th</sup> August 2016 (Case No. 32 of 2016) for TPC-G Trombay Unit 8.

<sup>\*</sup> For each Period, if the Monthly Load Factor on the basis of Monthly Contracted Capacity is less than 85%, the Fixed Charge will increase as per Schedule-2 of the PPA.

### **Energy Charges:**

7. In addition to the payment of Fixed Charges, as above, NUPLLP shall also pay Energy Charges, ex-bus, based on the energy scheduled for each time block during any billing month on the Commission notified normative operating parameters for TPC-G, Trombay Unit 8 and actual landed fuel cost applicable for each billing month.

## Waive the RPO obligation of NUPLLP upto FY 2019-20

8. NUPLLP has not considered procurement from any Co-generation or Renewable sources of energy for the reason of uncertainty in growth of the load trajectory. It is proposed that such mandatory conditions of fulfilling RPO to be waived off upto FY 2019-20.

# Waiver of UI/ Deviation Charges

- 9. It is proposed for a waiver from UI/Deviation charges, SLDC Charges and Scheduling/Re-Scheduling charges for first year due to low energy volume and low level of accuracy in scheduling which impacts on tariff because of huge amount of those charges corresponding to low volume of energy sale.
