The Commission vide its Order in Case No 113 of 2018 dated 24 April, 2018 extended the applicability of Generic Tariff Order dated 28 April, 2017 for FY 2017-18 in Case No 33 of 2017 for RE technologies along with its related terms and conditions, till 31 July, 2018 or the issue of new RE Generic Tariff Order, whichever is earlier.
