**Inviting Comments, Suggestions and/or Objections on the Report submitted by**  
**Maharashtra Energy Development Agency (MEDA) for Review of Classification of Wind**  
**Zone for the State of Maharashtra**

1. Maharashtra State Electricity Distribution Co. Ltd (MSEDCL) filed a Petition under Case No. 152 of 2018 for review of the Commission's Order dated 3 April, 2018 in Case No. 41 of 2017 seeking revision in Wind Zone of Projects with consistently higher generation.
2. The Commission vide its Order dated 9 July, 2018 in Case No 152 of 2018 allowed the Review and directed Maharashtra Energy Development Agency (MEDA) to review the Wind Zone classification of Wind Generators at the end of FY 2018-19 based on the actual generation data submitted by MSEDCL /Generators.
3. Accordingly, MEDA submitted its Report to the Commission on 28 February, 2019. As required under MERC (Conduct of Business) Regulations, 2004, said report was shared with MSEDCL for their comments. MSEDCL submitted its comments on 22 April 2019.
4. Now, in pursuance of its Order dated 9 July, 2018 in Case No. 152 of 2018, the Commission deems it fit to undertake public consultation process on the Report submitted by MEDA and comments received from MSEDCL.
5. Accordingly, the Commission invites written comments, suggestions and/or objections on the Report submitted by MEDA and the comments submitted by MSEDCL.
