M/s Eon Kharadi Infrastructure Pvt. Ltd. has been notified as "Developer" by Ministry of Commerce & Industry, Government of India under Special Economic Zones Act, 2005, for Special Economic Zone located at Kharadi, District:-Pune for the IT and ITES SEZ at MIDC Knowledge Park, Survey No.77, Kharadi, Pune (EON SEZ Phase I) and for the IT and ITES SEZ at Survey No.72, Kharadi, Pune (EON SEZ Phase II)

In accordance with section 14 (b) of Electricity Act, 2003 (EA, 2003) read with sub-section (1) of section 4 of Special Economic Zones Act, 2005 (SEZ Act), M/s Eon Kharadi Infrastructure Pvt. Pune for the IT and ITES SEZ at MIDC Knowledge Park, Survey No.77, Kharadi, Pune (EON SEZ Phase I) and for the IT and ITES SEZ at Survey No.72, Kharadi, Pune (EON SEZ Phase II) is a deemed distribution licensee to operate and maintain a distribution system for supplying electricity to the consumers in aforesaid SEZ area as specified in the SEZ notifications of Government of India. The Commission vide Order dated 5 June, 2020 in Case No. 67 of 2020 and 68 of 2020 has confirmed the deemed distribution licensee status of M/s Eon Kharadi Infrastructure Pvt. (EON).
