## INVITING COMMENTS IN PROCEEDINGS FOR VERIFICATION OF RENEWABLE PURCHASE OBLIGATION COMPLIANCE TARGETS FOR FY 2014-15 BY DISTRIBUTION LICENSEES IN MAHARASHTRA.

As per the provision of its Renewable Purchase Obligation, its compliance and Implementation of REC framework Regulations, 2010, the Maharashtra Electricity Regulatory Commission (the Commission) verifies the compliance of Renewable Purchase Obligation (RPO) targets by Distribution Licensees on yearly basis. Accordingly, based on the data submitted by Maharashtra Energy Development Agency (MEDA), the Commission initiated proceedings for FY 2014-15 vide following Cases and directed Distribution Licensees to submit details of compliance of RPO targets for FY 2014-15 to the Commission.
