Inviting comments on draft Maharashtra Electricity Regulatory Commission (Specific Conditions of Distribution Licence applicable to M/s. Newfound Properties and Leasing Pvt. Ltd. for IT & ITES SEZ at MIDC Trans-Thane Creek Industrial Area, District Thane) Regulations, 2018

M/s. Newfound Properties and Leasing Pvt. Ltd. has been notified as "Developer" by the Ministry of Commerce & Industry, Government of India, under the Special Economic Zones (SEZ) Act 2005, for the SEZ located at MIDC Trans-Thane Creek Industrial Area, District Thane.

In accordance with section 14 (b) of Electricity Act, 2003 (EA, 2003) read with Section 4 (1) of the SEZ Act, 2005, M/s. Newfound Properties and Leasing Pvt. Ltd is a deemed Distribution Licensee to operate and maintain a distribution system for supplying electricity to the consumers in the SEZ area as specified in the SEZ notification of Government of India. The Commission, vide Order dated 2nd February, 2018 in Case No. 80 of 2017, has confirmed the deemed Distribution Licensee status of M/s. Newfound Properties and Leasing Pvt. Ltd.

Under Section 16 of the EA, 2003, the Commission has prepared the draft Maharashtra Electricity Regulatory Commission (Specific Conditions of Distribution Licence applicable to M/s.
