- 1. Heard the advocates of the Petitioners and the Respondent.
- 2. The Advocate of the Petitioner in Case Nos. 31 and 37 of 2022 stated that the Hon'ble Supreme Court vide its judgment dated 25 July,2022 in Civil Appeal No. 6291 of 2021(MSEDCL v/s Jindal Poly Films Ltd.) has granted the stay to the APTEL's Order in Appeal No. 70 of 2019 on the matter related to the Power Factor (**PF**) Incentive on Open Access consumption.
- 3. Further, the Advocates of the Petitioners stated that the present matter raised in these 3 Cases regarding applicability of PF Incentive on Open Access consumption and the matter in Civil Appeal No. 6291 of 2021 are similar. Hence, they requested for adjournment till the Hon'ble SC disposes off the matter or stay is vacated in Civil Appeal No. 6291 of 2021.
- 4. Advocate of MSEDCL also confirmed the stay to the APTEL's Order in Appeal No. 70 of 2019 by Hon'ble SC and also provided copy of the aforesaid judgement.
- 5. The Commission accepted the request of the Petitioners and adjourned these Cases.

Next date of hearing will be communicated by the Secretariat of the Commission after the decision of the Hon'ble Supreme Court in the Civil suit No. 6291 of 2021.
