Ltd.) seeking Review under regulation 85 of the MERC (Conduct of Business) Regulations, 2004 read with section 94 (1) (f) of the Electricity Act, 2003 of the Common Order dated 16.03.2022 passed by this Hon'ble Commission in Case No. 175/2017 and petition seeking review of the observations/directions qua injection of power from "non-captive generating units of SWPGL or excess consumption from the grid"
