Advocates of the Petitioners and Respondent in Case No. 199 of 2018, 245 of 2018 & 273 of 2018 appeared before the Commission as per the Hon'ble ATE Judgment dated 6 October 2022 & 17 October 2022.

The Commission noted that in these matters, Hon'ble ATE has directed the Commission to undertake exercise of determination of amount due, considering the payments which have been made over the period, including DPC and associated carrying cost, if any. Further, it is directed to pass an Order within one months from the date of first appearance of parties.

Considering time bound nature of directives, Advocate of the Petitioners undertake that she will be filing submission by end of the day. The Commission directs MSEDCL to respond to the Petitioner's statement within seven (7) days thereafter. The Petitioners may file Rejoinder, if any, within three (3) days thereafter. In order to quantify the claim amount, Petitioner shall provide excel sheet of its computation clearly showing monthly amounts and formulas used for such computation. MSEDCL shall respond on same excel sheet pointing out difference of opinion, if any, with supporting justification.
