1. Heard the Advocates / Representatives of the Petitioner, Respondents and Applicants.

- 2. Advocate of the Petitioner stated that some Respondents have filed Applications on Maintainability of the Petition, one application has been filed for impleadment and some Respondents have filed applications for striking off their names as Respondents. The Advocate of petitioner sought 6 weeks' time for filing a consolidated reply to all the submissions of the Respondents.
- 3. Mr. Sanjay Sen (Adv.), appearing for some Respondents stated that MSEDCL had filed an Appeal before the Hon'ble Appellate Tribunal for Electricity (APTEL) wherein the same issues were raised before the Hon'ble APTEL. The said Appeal was subsequently withdrawn by MSEDCL, and the present Petition has been filed before the Commission. He stated that MSEDCL has not made any disclosure in its Petition regarding the said Appeal that was filed before the Hon'ble APTEL. He stated that some parties have filed Writ Petition before the Hon'ble Bombay High Court against the present Petition wherein the Hon'ble Bombay High Court has dismissed the Writ Petition leaving all contentions open, including the question of jurisdiction.
- 4. Mr. Sakya Chaudhari (Adv.) appearing for some Respondents/ Applicants stated that the Petition was required to be first heard on Maintainability before deciding on the merits as the issues raised in the Petition are generic in nature. He further stated that the Commission should direct MSEDCL for striking off their names as such cases are not covered by the present Petition.
- 5. Mr. Avijeet Lala (Adv.), appearing for some Respondents, stated that the present Petition has been filed in the month of July 2022. He stated that the present Petition has cast uncertainty among the consumers and the captive generators due to which investments have been held up. He therefore, requested the Commission to issue time bound directions to decide the present Petition.
- 6. Mr. R. B. Goenka (Rep.) stated that time sought by MSEDCL for filing replies to Respondent submissions may not be granted. He stated that some Respondents do not have a

sale and purchase arrangement and such cases do not qualify under the first prayer of MSEDCL in its Petition.

- 7. On enquiry by the Commission, MSEDCL stated that it had no objection to the Impleadment Application filed by the Captive Power Producers Association.
- 8. The Commission has taken note of the submissions of Petitioner and Respondents and other Applicants. In the interest of justice, the Commission deems it fit to grant time sought by MSEDCL to file rejoinder to the Respondents submissions and other Miscellaneous Applications filed.
- 9. Having heard the Parties, the Commission directs as under:
 - i. Impleadment of Captive Power Producers Association is allowed as a Respondent to the case.
 - MSEDCL shall update the Petition with all relevant information specific to every respondent and serve the same to all the Respondents and other Applicants in the matter.
 - iii. MSEDCL shall file its rejoinder to all the submissions of the Respondents including applications by some of the Respondents for striking off their names as Respondents within 6 weeks' time.
- 10. In the next Hearing, the Petition along with associated IAs shall be taken up for hearing on the following issues:
 - i. Maintainability of the Petition filed by MSEDCL; &
 - ii. Applications filed by the Respondents for striking off their names.

Next date of hearing will be communicated by the Secretariat of the Commission.
