Subject: Petition of SMW Ispat Private Ltd. (Formerly known as Mahalaxmi TMT Pvt. Ltd.) under Regulation 39 of the MERC (Distribution Open Access) Regulation, 2014 against MSEDCL for adjudication of dispute arising under Open Access and petition challenging the “Revised Supplementary Bill” dated 11.08.2022 issued by MSEDCL as the same has not only been raised without any details/explanations but is also completely contrary to this Hon’ble Commission’s Order dated 19.03.2018 in Case No. 159/2016 and Judgment dated 26.11.2021 in Appeal No. 106/2021 passed by the Hon’ble APTEL.
