Subject: Petition filed by Ideal Energy Projects Limited (IEPL) under Section 86(1)(a) and 86(1)(f) seeking directions against Maharashtra State Electricity Distribution Company Limited to apply HT-I Industrial Tariff category to the start-up power consumed by the Petitioner and accordingly issue appropriate refund / credit towards excess amount collected from the Petitioner for the period 27.12.2012 till 31.05.2015 under HT-II Commercial Tariff category along with applicable interest.
