Petition of M/s Eon Kharadi Infrastructure Private Limited seeking approval for power procurement plan along with Tender documents for procuring power through Renewable Energy Sources with Energy Storage facility on Long Term Basis for 15 years

Daily Order

- 1. Heard the Advocate & Representative of the Petitioner.
- 2. Advocate of the Petitioner mentioned that while preparing bidding documents, it has adopted the broad principles from SECI's RfS document dated 2 September 2022. He further stated that they have formally approached SECI for allotment of power, but in case SECI does not allocate, it needs to procure power on its own and hence filed the preset Petition.
- 3. Having heard, the Commission made following observations:
 - a. Petitioner shall first complete its discussion with SECI. Being part of SECI's large quantum bid may fetch competitive advantage in terms of discovered tariff vis-à-vis floating bid for small quantum of EON SEZ.
 - b. In case it does not get power allocation from SECI, then Petitioner shall file following additional details:
 - i. Demand-Supply projections for 15 years to establish quantum for which bid needs

to be floated.

- ii. Generation mix which would be best suited for load curve of EON and will also comply with all regulatory requirements (DSM, RE DSM etc).
- iii. EON has relied upon SECI's bid document which has option of supplementing RE power with thermal sources whereas EON's proposal is for 100% RE power. The Commission has recently approved bid documents of MSEDCL for procurement of RE RTC power, EON may refer to such Bid documents.
- iv. Comparative chart showing changes from reference document (SECI Bid / MSEDCL Bid) needs to be submitted.
- c. The Commission also suggested EON to get its demand-supply projections approved in upcoming MTR process and then initiate long term procurement process.
- 4. Considering above observations of the Commission, Petitioner is required to clarify whether it wish to peruse this Petition or would like to withdraw the same with liberty to file the petition afresh at appropriate time.
- 5. Post receipt of above submission, the Commission will decide next course of action in the matter.
