**Daily Order**

1. Heard the Advocates of the Petitioners/ Applicants and MSEDCL.
2. Advocate of the Petitioners/ Applicants stated that MSEDCL vide Notice dated 5 January 2023 and 9 January 2023 directed concerned Petitioners to install meter at individual wind turbine locations within a period of 7 days, otherwise necessary action may be initiated as per the provisions of Wind Energy Purchase Agreements (WEPA). Thereafter, few Wind Generators approached the Hon'ble Bombay High Court seeking interim protection from disconnections. The Hon'ble Bombay High Court vide Order dated 17 January 2023 granted liberty to these Wind Generators for approaching before the MERC and directed MSEDCL to not take any coercive action till 31 January 2023. In view of the above present Applications has been filed for mentioning of these matters for urgent listing.
3. The Commission notes that some Petitioners (Sispara Renewables and Kalsubai Power) have protections from the Hon'ble Bombay High Court from disconnection of its Wind Turbines, whereas some other Petitioners (Nu Power and Rajlaxmi Minerals ) have approached directly before the Commission. These Petitioners have requested the Commission to restrain MSEDCL from taking any coercive action till the disposal of the present matters.
4. **In view of the above circumstances, the Commission is listing these matters for urgent hearing on Tuesday, 7 February 2023 at 12.30 pm and till that time or further Order in these matters, MSEDCL shall not take any coercive action against the above petitioners or any of the similarly placed Wind Generators.**
