PUBLIC NOTICE

Inviting comments on draft Maharashtra Electricity Regulatory Commission (Specific Conditions of Distribution Licence applicable to M/s. Gigaplex Estate Pvt. Ltd. for IT & ITES SEZ at Airoli Knowledge Park, TTC Industrial Area, Airoli, Distt. Thane) (Third Amendment) Regulations, 2023

The Maharashtra Electricity Regulatory Commission (MERC) has notified the MERC (Specific Conditions of Distribution Licence applicable to M/s. Gigaplex Estate Pvt. Ltd. for IT & ITES SEZ at Airoli Knowledge Park, TTC Industrial Area, Airoli, Distt. Thane) Regulations, 2015 (**‘the principal Regulations’**) on 23 December, 2015 which have been subsequently amended on 3 February 2017 and on 21 September 2018 to reflect the revised licence area of 16.52 Hectares.

Pursuant to the Notification dated 1 June 2021 issued by the Ministry of Commerce and Industry (Department of Commerce), Government of India, the Licence area of Gigaplex Estate Pvt. Ltd (**GEPL**) has been revised from 16.52 Hectares to 8.04 Hectares due to denotification of an area of 8.57 Hectares at Survey No. 145 (Pt.), 146 (Pt.), 147 (Pt.) 148 (Pt.), 149(Pt.) and 153 (Pt.) at Airoli Village, Survey No. 208 (Pt.) at Digue Village and the addition of an area of 0.09 Hectares at Survey No. 145 (Pt.) at Airoli Village. The Commission, vide Order dated 29 July 2022, has allowed the change in the area of supply in principle.

The Commission accordingly proposes to amend the principal Regulations to the extent of the change in the area of supply. The draft of the amendment is available on the Commission’s website, www.merc.gov.in (https://www.merc.gov.in/regulation_type/draft-regulations/) in downloadable format.
