Inviting comments on draft Maharashtra Electricity Regulatory Commission (Specific Conditions of Distribution License applicable to P-One for IT & ITeS SEZat Rajiv Gandhi Infotech Park, MIDC, Hinjewadi Phase III, Pune)Regulations, 2023

M/s. P-One Techpark Private Ltd. has been notified as "Co-Developer" by the Ministry of Commerce & Industry, Government of India under Special Economic Zones Act 2005, for IT & ITeS SEZ admeasuring 223.56 Hectares at MIDC, Hinjewadi Phase III, Pune.

In accordance with section 14 (b) of Electricity Act, 2003 (EA) read with sub-section (1) of section 4 of Special Economic Zones Act, 2005 (SEZ Act), P-One Techpark Private Ltd. is a deemed Distribution Licensee to operate and maintain a distribution system for supplying electricity to the consumers in aforesaid SEZ area as specified in the SEZ Notification No. S.O. 934 (E) dated 7 June 2007 of Government of India. The Commission vide Order dated 6 October, 2022 in Case No. 91 of 2022 has confirmed the deemed distribution licensee status of M/s. P-One Techpark Private Ltd.
