



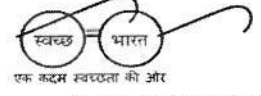

Sir,

The office of the Commission is in receipt of your application dated 18.08.2022 under section 6 (1) RTI Act 2005 seeking information by the PIO.

Further, vide e-mail dated 23.08.2022 and 29.08.2022 you have requested that to provide inspection at the earliest and gave date and time for the inspection of the office files and subsequently provide the required documents.

Further, vide e-mail dated 12.09.2022 it was requested by you to reschedule the date of inspection to 13.09.2022 after 02.00 PM. As per your request the inspection was rescheduled on 13.09.2022 at 02.00 PM onwards (within office hours) in the Office of the Commission and same was informed to you vide e-mail dated 12.09.2022.

Accordingly, you were present at the office of the Commission for inspection on 13.09.2022 at 02.30 PM. Also Shri Arun Walunj Public Information Officer & Under Secretary and Shri Pradeep Mohare, Section Officer was also present through the office of the Commission.


