**Subject: -** Petition filed by Adani Electricity Mumbai Ltd.-Distribution seeking directions against Tata Power Company Ltd.-Distribution for willful violation of the Order dated 12 June 2017 passed by the Commission in Case Nos. 182 of 2014 and 40 of 2015, while carrying out switchover of existing consumers in Mumbai Suburban area.
