### **Daily Order**

1. Heard the Advocate of Petitioners and Respondent.

- 2. The Commission notes that main contention in the Petition is about non issuance of unconditional No Objection Certificate (NOC) by MSETCL for firming up of Long Term Access (LTA) with CTU for the Petitioner's 300 MW Project which has ultimately led to Petitioner initiating process for termination of PPA. Therefore, the Commission is of the opinion that MSETCL needs to be impleaded in the matter so that its submission on difficulties in issuing un-conditional NoC can be heard.
- 3. Advocate of the Petitioner agreed for the same. However, she requested that in the meantime MSEDCL may be directed not to take any coercive step in terms of encashment of its PBG. She stated that PBG is valid till May 2024.
- 4. In view of above, the Commission adjourned the hearing with direction to the Petitioner to implead MSETCL in the matter and serve the copy of the Petition immediately. MSETCL shall file its reply within 2 weeks thereafter. Rejoinder, if any shall be filed within 1 week from the date of reply from MSETCL.
- 5. Further, as PBG is valid till May 2024, the Commission directs MSEDCL not to take any coercive action, till final disposal of the matter.

IA No.30 of 2023 stands disposed of. Subsequent to receipt of above submissions, next date of hearing in Case No. 56 of 2023 will be intimated by the Secretariat of the Commission.
