Ltd. under Section 86(1)(e) and (f) of the Electricity Act, 2003, read with Regulation 32 and 92 to 94 of the MERC (Conduct of Business) Regulations, 2004, challenging the illegal and arbitrary actions and conduct on the part of the MSEDCL, in disconnecting the petitioner's wind power plant from its distribution system / grid, without prior intimation, basis or affording an opportunity for justification and in derogation of the extant clauses of the relevant energy purchase agreements executed by and between the petitioner and MSEDCL.
