**Subject: -** Petition of **Sai Wardha Power Generation Private Limited** under Section 86(1)(f) of the Electricity Act, 2003 and Article 14.3 of the Power Purchase Agreement dated 02.07.2020 entered into between the Petitioner and the Respondent, seeking adjudication of dispute on Respondent's unilateral post facto decision to deduct Energy Charges for Energy supplied by the Petitioner and consumed by the Respondent.
