**Subject:** Petition of **Adani Power Maharashtra Limited** under Section 86 of the Electricity Act, 2003 read with Article 13/10 ("Change in Law") of the Power Purchase Agreement dated 08.09.2008 and 31.03.2010 / 09.08.2010 / 16.02.2013 for 1320MW and 1200 MW /125 MW /440 MW respectively executed between Adani Power Maharashtra Limited (amalgamated with Adani Power Limited) and Maharashtra State Electricity Distribution Company Limited in respect of relief for additional cost of Transportation in compliance with the Notification issued by the Ministry of Environment, Forest and Climate Change dated 25.01.2016.

- a.
