- 2. The quorum at M-DNAC meeting shall be two members, of whom one shall be the External Member of the M-DNAC and one shall be the officer of the Commission/Ombudsman.
- 3. The role of the M-DNAC is stipulated Chapter 6 of the Commission's Order. While performing its function, M-DNAC shall also be guided by the various considerations elaborated elsewhere in the Order dated 12 June, 2017.
- 4. M-DNAC shall prepare the Guidelines for consideration of the norms for deciding the estimated load based on which the cost estimates are formed and to be evaluated for deciding the least cost licensee. These Guidelines shall be finalized after due consultation of the Licensees and approval of the Commission.
- 5. The Distribution Licensees viz. Adani Electricity Mumbai Ltd. and Tata Power Co. Ltd. shall provide timely inputs as may be required by the Committee.

6. The Notification dated 28 June, 2017 for "Constitution of Mumbai Distribution Network Assessment Committee (M-DNAC) in pursuance of Order dated 12 June, 2017 in Case Nos. 182 of 2014 and 40 of 2015" stands superseded by this Notification.
