Subject: - Petition of **Haldirams Food International Pvt Ltd.** under Regulation 16.2.4 of the MERC (Electricity Supply Code and Standards of Performance of distribution licensees including power quality) Regulations, 2021 challenging the “debit bill adjustment” amounting to Rs. 2,79,19,643.09 included by MSEDCL in the petitioner’s monthly energy bill dated 07.01.2023 and under Section 142, 146 and 149 of the EA, 2003 against MSEDCL seeking initiation of appropriate proceedings for violation of provisions of Regulations framed by this Hon’ble Commission including but not limited to violation of provisions of EA, 2003 and petition in the matter of MSEDCL’s commercial circular bearing no. 266 dated 30.07.2016 read with MSEDCL’s commercial circular bearing no. 289 dated 06.06.2017 adopting the government of Maharashtra resolution bearing no. 238/urja/-5 dated 29.06.2016 alongwith the modified government of Maharashtra resolution bearing no. 238/urja/-5 dated 24.03.2017 and thereby providing incentives to Marathwada, north Maharashtra and d & d+ areas and providing the applicable incentive to the petitioner for the period september-2019 to march-2022

1.
