Daily Order

1. Heard the Advocates for the Applicant/ Petitioner and Respondent.
2. Advocate for Petitioner sought for Ex-party Interim relief in IA 55 of 2023 and stated that wheeling charges shall not be levied by MSEDCL on Petitioner's Captive Open Access transactions for future months till pendency of Petition in Case No. 177 of 2023.
3. He further stated that the Commission in similar matter in Case No. 151 of 2023 which was heard on 11 August 2023 directed MSEDCL to file its reply within weeks' time, however, MSEDCL is yet to file its reply.

4. Advocate of the MSEDCL stated that there was delay in filing the reply due to certain reasons and they will file its reply in Case No. 151 of 2023 by tomorrow i.e 23 September 2023.
5. **In view of the above, the Commission allowed Interim Relief for not levy of wheeling charges by MSEDCL in the Open Access Invoices for future months till the pendency of Petition in Case No. 177 of 2023.**
6. **Having heard the Parties, the Commission directs MSEDCL to file its Reply to Main Petition in Case No. 151 of 2023 by tomorrow i.e 23 September 2023 and in Case No. 177 of 2023 within a week's time. The Petitioner to file its Rejoinder, if any in both the cases thereafter within one week time.**

After the receipt of the above submissions from the Parties, the next date of the hearing will be communicated by the Secretariat of the Commission.
