Daily Order

1. IA No. 56 of 2023 was filed by the Petitioner requesting urgent listing of its case registered as Case No. 39 of 2023.
2. Justifying urgency, Advocate of the Petitioner stated that originally TPC-D has filed the Petition for approval of power procurement plan in February 2023. As per directives of the Commission vide daily Order dated 18 July, 2023, TPC-D has impleaded State Transmission Utility, State Load Despatch Centre and Other distribution Licensee and has filed the amended Petition on 4 August, 2023. As power procurement plan starts from FY 2024-25, TPC-D would require time to carry out competitive bidding.
3. The Commission observed that replies from 2-3 respondents have been filed in the matter. Considering the urgency cited, the Commission directs other Respondent to file their Reply, if any, within 7 days. Petitioner to file rejoinder, if any, within 7 days thereafter.
4. **E-Hearing in Case No. 39 of 2023 is scheduled on Friday, 6 October 2023.**
