**Subject: -** Petition of Acme Heergarh Powertech Private Limited (AHPPL) under section 86 of the EA, 2003 before the MERC for (i) approval of “Change in Law” and (ii) seeking an appropriate mechanism for grant of an appropriate adjustment/compensation to offset financial/ commercial impact of change in law event on account of increase in the rate of CGST / IGST on Renewable Energy Devices from 5% to 12% on account of amendment to Notification No. 01/2017-Central Tax (Rate) and Notification No. 01/2017-Integrated Tax (Rate) dated June 28, 2017 vide Notification No. 8/2021-Central Tax (Rate) and Notification No. 8/2021- Integrated Tax (Rate) dated September 30, 2021 (effective October 1, 2021) respectively, in terms of Article 9 of Power Purchase Agreement dated 21.08.2019 between M/s ACME Heergarh Powertech Private Limited and MSEDCL.

1.
