**Subject: -** Petition of M/s. Reddy Construction under Section 86(1) of the EA 2003 for (i) approval of “change in law” and (ii) for seeking a compensation against additional cost incurred on account of implementation of the goods and services tax on procurement of solar modules and other solar equipment increased from 5% to 12% vide notification number 08 of 2021, notification issued in relation thereto by the state of Maharashtra, -central tax (rate) dated 30.09.2021 read with notification number 08 of 2021 - integrated tax (rate) dated 30.09.2021 in terms of article 9 of the PPA dated 04.02.2022 entered between M/s. Reddy Construction and MSEDCL for development of 3 MW capacity power project at village – Gondri, Lodga, Tehsil - Ausa, District - Latur.
