**Subject: -** Petition of M/s. Karnataka Resco Rooftop Solar Pvt. Ltd. under Section 86(1) of the Electricity Act 2003 for (i) Approval Of “Change In Law” and (ii) Seeking an appropriate mechanism for grant of an appropriate adjustment/compensation to offset financial/ commercial impact of change in law events on account of the change in rates of GST on procurement of solar modules and other solar equipment increased from 5% to 12% which are the primary components required for setting up of solar power plants and the increase in composite rate of GST on EPC contracts to 13.80%, due to introduction of Notification No. 24 of 2018 dated 31.12.2018 and Notification No. 08 of 2021 dated 30.09.2021 in Terms of Article 8 of the Power Purchase Agreement dated 13.01.2020 entered between M/s. Karnataka Resco Rooftop Solar Pvt Ltd. and MSPGCL for development of 10 MW capacity at Pedgaon, Tal- Hingoli, District-Hingoli, Maharashtra.

1.
