**Subject: -** Petition of Maharashtra State Electricity Distribution Company Limited (MSEDCL) seeking approval for adoption of Tariff discovered for long term procurement of 49.7 MW Solar Power under 'Pradhan Mantri Kisan Urja Suraksha Evam Uthhan Mahabhiyan' (Pm-Kusum) under component a from 0.5 to 2 MW capacity projects connected to distribution network under Section 63 of the Electricity Act 2003 for meeting the Solar Renewable Purchase Obligations.
