**Subject: -** Petition of Maharashtra Industrial Township Limited (MITL) Erstwhile Aurangabad Industrial Township Limited (AITL) for approval of power purchase rate for purchasing of power from Solar Power Project for three years' period and approval for executing the Power Purchase Agreement, under the provisions of Section 86 (1) (b) of the Electricity Act, 2003 read with Regulation 3.2, and Regulations mentioned under "Part C: Power Procurement" of the Maharashtra Electricity Regulatory Commission (Multi-Year Tariff) Regulations, 2019 along with Regulation 8.3.3 of the Maharashtra Electricity Regulatory Commission (General Conditions of Distribution License) Regulations, 2006.
