Interlocutory Application of Ultratech Cement Limited for urgent listing of matter in Case No. 19 of 2024 and seeking compliance of the Commission's common Order dated 27 December 2023 in Case No. 151 of 2023 & Others, by Maharashtra State Electricity Distribution Company Limited

Daily Order

1. Heard the Advocates for the Applicant/ Petitioner and Respondent.
2. Advocate for Petitioner stated that the Commission vide common Order dated 27 December 2023 in Case No. 151 of 2023 & Others (Jubilant Ingrevia Ltd. & Others Vs MSEDCL) directed MSEDCL not to levy Wheeling Charges and Wheeling Losses on the power sourced through Transmission Open Access. However, in spite of such directions, MSEDCL has levied Wheeling Charges and Wheeling Losses and issued the disconnection Notice to the Petitioner. Therefore, the Petitioner sought urgent listing of the present case for relief.
3. **Having heard the Parties, the Commission directs as under:**
 - i. **MSEDCL shall not levy Wheeling Charges and Wheeling Losses in the Open**


Access monthly Invoices till the pendency of Petition in Case No. 19 of 2024 and there shall not be any disconnections thereof, as a compliance to the common Order dated 27 December 2023 in Case No. 151 of 2023 & Others.

- ii. MSEDCL shall file the compliance of common Order dated 27 December 2023 in Case No. 151 of 2023 & Others within fifteen (15) days.**
- 4. After the receipt of the above compliance, the next date of the hearing of Case No. 19 of 2024 will be communicated by the Secretariat of the Commission.**
- 5. With the above, IA No. 8 of 2024 in Case No. 19 of 2024 for urgent listing stands disposed of.**
