1. IA No. 65 of 2023 was filed by the Petitioner for urgent listing of its matter in Case No 189 of 2023.
2. Advocate of the Petitioner stated that the Commission has directed BEST to extend power purchase Agreement with TPC-G on the existing terms and condition for FY 2024-25 vide Order dated 15 March 2023 in Case No 240 of 2022 but TPC-G has shown its inability to extend the PPA for one year i.e for FY 2024-25. Further the said Order has not been challenged by TPC-G and is binding on them. In view of that, as the power purchase planning of BEST for FY 2024-25 depends on the outcome of the present case, BEST requested the Commission to keep the matter for an early hearing.
3. Considering the urgency, the Commission listed Case No 189 of 2023 for e-hearing on **Friday, 8 December 2023.**
