**Subject: -** Petition of Maharashtra Industrial Township Limited (MITL) Erstwhile Aurangabad Industrial Township Limited (AITL) for adoption of tariff discovered through competitive bidding process by MITL (Erstwhile AITL) for the period starting from 01.12.2023 to 30.11.2024 (12 Months) under Section 86 of the Electricity Act, 2003 (EA) read with “Guidelines for short-term (i.e. for a period of more than one day to one year) Procurement of Power by Distribution Licensees through Tariff based bidding process” dated 30th March, 2016 issued by Ministry of Power, Government of India.
