1. Heard the Advocate/ Representative of the Petitioners and Respondent.
2. Advocate of Respondent brought out to the notice of the Commission that MSEDCL has filed Writ Petitions against CGRF Nashik Orders dated 15 February 2019 and 16 February 2019. Hon'ble the Bombay High Court in its interim Order dated 11 October 2023 had directed not to take coercive actions till next date. In the subsequent hearings, Hon'ble the Bombay High Court has continued the ad-interim relief granted earlier till 04 March 2024.
3. In view of the above, the Commission adjourned the matters and directed to keep abeyance till further happenings in the Writ Petitions pending before Hon'ble the Bombay High Court.
4. The Commission directs Petitioners and MSEDCL to provide updated status of the Writ Petitions after hearing before Hon'ble the Bombay High Court.
