PUBLIC NOTICE

Inviting Suggestions and/or Objections on the Draft Specific Conditions Regulations applicable to M/s. SEZ Bio-Tech Services Pvt. Ltd.'s Manjari SEZ and Hadapsar SEZ.

- The Commission vide its common Order dated 8 December 2023 in Case Nos. 179 and 180 of 2023 confirmed the status of M/s. SEZ Bio-Tech Services Pvt. Ltd. as the deemed Distribution Licensee for the following notified Special Economic Zone (SEZ) under Section 14 of the Electricity Act, 2003 (EA):
 - Sector-specific Special Economic Zone (SEZ) for Biotechnology admeasuring 22.4226 Hectares at Manjari Budruk, Taluka Haveli, District Pune
 - ii) Sector specific SEZ for Biotech and Pharmaceuticals Sectors admeasuring 12.4136 Hectares at Hadapsar/Manjari Village, Pune.
- 2. Under Section 16 of the EA, the Commission may specify general or specific conditions applicable to a Licensee, and these conditions shall be deemed to be conditions of its Licence. Accordingly, the Commission in the aforesaid Order stated it shall separately notify the Regulations specifying the specific conditions of Licence applicable for these notified SE7s.
- 3. The Commission has prepared the draft MERC (Specific Conditions of Distribution License applicable to M/s SEZ Bio-Tech for the sector specific SEZ for the Poonawalla Biotechnology Park at Manjari Village, District Pune) Regulations, 2024 and the draft MERC (Specific Conditions of Distribution License applicable to M/s SEZ Bio-Tech for the sector specific SEZ for Biotech and Pharmaceuticals Sectors at Hadapsar Village, District Pune) Regulations, 2024. These draft Regulations are available on the Commission's website, www.merc.gov.in (https://www.merc.gov.in/regulation_type/draft-regulations/) in downloadable format.
- 4.
