Subject: - Petition of Sunstream Green Energy One Private Limited (formerly known as Eirene Navals System Private Limited) under Section 86(1) of the EA, 2003 for approval of change in law and seeking compensation against the additional expenditure incurred on account of increase in rate of goods and service tax (GST) from 5% to 12% on renewable energy devices and parts for their manufacture including solar modules, solar inverters vide notification No.8/2021- integrated tax (rate) dated 30.09.2021 of Central Government, notification No.8/2021- central tax (rate) dated 30.09.2021 of Central Government and notification No.08/2021- state tax (rate) of finance department- Government of Maharashtra in terms of article 9 of the Power Purchase Agreement executed between Sunstream Green Energy One Private Limited and MSEDCL inter-alia for generation and supply from 10 MW solar power project located at village Navindagi and Goudgaon Budruk, Taluka Akkalkot, District Solapur, Maharashtra.
