Ltd.** under Section 94 (1) f of the Electricity Act, 2003 read with Order 47 Rule 1 of the Code of Civil Procedure, 1908 and Regulation 85 of the Maharashtra Electricity Regulatory Commission (Conduct of Business) Regulations, 2004 for review of the Order dated 27.09.2023 passed by the Hon'ble Commission in Case No. 162/AD/2022 seeking compensation from Kreate Energy India Pvt.
