**Subject:** - Petition of Sahyadri Industries Limited (SIL) for non-compliance of provisions of EA, 2003 Particularly Sections 42, 45, 46, 86, 142 & 146 of the EA, 2003 Read With Regulations 14, 32 & 37 of the MERC (Distribution Open Access) Regulations, 2016 read with MERC Practice Directions (Processing Of Open Access Applications) dated March 8, 2017 by MSEDCL for refund of Amounts on account of adoption of incorrect billing methodology for FY 2016-17 to FY 2023-2024 & seeking directions against MSEDCL for non-compliance of Various Orders of this Hon'ble Commission and Hon'ble Appellate Tribunal for Electricity.
